Canadian Urban History

CONTENT:

History of the urban development of Canada from New France to the present day. Seminar format. Course is divided into two parts, the first focusing on Canada's early modern settlement, industrialization in the 19th century, and the formation of the Canadian Dominion. The second half covers the 20th and 21st century sequels: integration with the United States, Canada's global role, increasing urbanization, technological and infrastructural development. The course focuses on Canada as a multicultural society with a vast cultural heritage. Readings provide students with a foundation for developing communication and critical thinking skills. The readings cover a spectrum of historians, emphasizing the theoretical and historiographical nature of the subject material. Students produce Primary Source Analysis to test research and thesis formulation skills. Midterm and final exam directly test students' learning and breadth of knowledge.

ASSIGNMENTS:

Primary Source Analyses (PSAs)

Each week when primary sources are assigned in the readings, students will select a source and write a brief response. Students must print out the PSA response and bring it to class. These written responses are collected and graded each week.

A quality source analysis will demonstrate that the student has:

- 1) Understood the importance of the document and reflected on its historical meaning.
- 2) Addressed fundamental questions such as the origin, author, objective and context of the document.
- 3) Written a concise appreciation of the document identifying what the student considers are key questions and areas of interest.

Midterm and Final Exams

The exams are formatted for short answer questions. Students should use their knowledge from readings, lectures, and their own research and knowledge to respond to questions as completely as possible.
